Change Computer Assisted Instruction (CAI) Policy to:

In their last quarter, all nursing students are required to take the Exit Exam which identifies strengths and weaknesses in knowledge and readiness for the NCLEX exam. If the required minimum score is not

met, the student will be required to repeat the associated course to fulfill completion requirements, as well as complete the Virtual-ATI to the "Green Light". The required outcomes are posted on the Nursing Bulletin Board. All students must complete the AIAM designated Live NCLEX Review.

Page 95

DELETE:

On test days, students arriving later than 10 minutes, regardless if the test has started or not, will not be allowed to sit for the test and will require approval from the Academic Dean (or Director of Nursing for nursing courses) to make-up the test at a later date (within 2 Testing days as published on the quarterly proctored Testing Schedule. Only the Academic Dean (or the Director of Nursing for nursing courses) can extend the make-up time in rare and extenuating circumstances). The student may be asked to leave the test situation until the test is over so there is no distraction for other students.

Replace with:

The first two times in each class students arriving later than 10 minutes on test days may not be allowed to sit for the test. The instructor will make the judgment call whether the student is permitted to join the test situation in progress or needs to schedule a make-up test during proctored testing sessions. The student may be asked to leave the test situation until the test is over so there is no distraction for other students.

If a student is late ten minutes or more a third time in a class, the student will be required to set an appointment within 48 hours with the Academic Dean (or the Director of Nursing for nursing courses) for a decision on whether permission will be granted to make-up the test. If the student does not make and keep the appointment, a 0 will be given for the missed test. All tests must be made up within 7 calendar days as published on the quarterly proctored Testing Schedule. Only the Academic Dean (or Director of Nursing for nursing courses) can extend the make-up time-frame in rare and extenuating circumstances).

Page 97, replace point 5. with:

The student must have a minimum GPA of 2.0 to apply for readmission. The Readmission Committee may approve an appeal for and waive the GPA requirement. The student will be placed on academic warning immediately upon readmission with an Academic Improvement Plan.
